
#### **METHODOLOGY**


- ➤ Total gross assets of Latvian commercial banks were EUR 23.20 billion as of December 31, 2019;
- ➤ The value of assets has increased by 1% or +0.25 billion EUR in the 4th quarter 2019;
- ➤ Total gross assets increased by 1% or +0.33 billion EUR in 12 months 2019;
- ➤ The value of total gross assets has stabilized in the last 12 months period at the level of 23 billion EUR.




# Change of gross assets 31.12.2019. vs 31.12.2018., MEUR




### Banks' gross assets 2000-2019 (1)




### Banks' gross assets 2000-2019 (2)



#### Capital of Latvian banking sector


- ➤ Total capital of the Latvian banking sector was EUR 2.67 billion as of December 31, 2019;
- ➤ Total capital decreased by 6% or EUR -0.16 billion in the 4th quarter 2019;
- ➤ Total capital decreased by 7% or EUR -0.19 billion in the last 12 months period;
- ➤ The largest capital value was reached in 2015, it was EUR 3.3 billion. Since then total capital has decreased by EUR -0.66 billion or 20%.




## Change of capital 31.12.2019 vs 31.12.2018, MEUR




### Banks' capital 2000-2019 (1)



#### Profit of Latvian banking sector 2000-2019



#### Profit of Latvian banking sector

- ➤ Total profit of commercial banks in Latvia was EUR 119 million in 2019;
- ➤ It was by EUR -175 million or 59% smaller compared to the result of 2018;
- > Latvian banking sector is profitable since 2012;
- ➤ Accumulated profit of Latvian banking sector is EUR 469 million since 2008 (economic crisis).


#### Change of profit 2019 vs 2018, MEUR




# Banks' profit 2015-2019, MEUR un % from total profit of Latvian banking sector (1)



# Banks' profit 2015-2019, MEUR un % from total profit of Latvian banking sector (2)





#### Loans at Latvian banking sector


- ➤ The portfolio of issued loans by Latvian banking sector was EUR 13.47 billion as of December 31, 2019;

- ➤ The portfolio decreased by 0.7% or EUR -0.10 billion in the last 12 months period;
- > Eight banks had loan portfolio increase in 2019.





### Change of property loans to residents 31.12.2019 vs 31.12.2018, MEUR






### Change of loans to companies 31.12.2019 vs 31.12.2018, MEUR










- ➤ Total deposits at Latvian banking sector were EUR 17.21 billion as of December 31, 2019;
















#### Capital adequacy ratio 2012-2019 (1)




#### Capital adequacy ratio 2012-2019 (2)




#### Capital adequacy ratio 2012-2019 (3)




#### Return on equity 2015-2019 (1)




#### Return on equity 2015-2019 (2)




#### Return on equity 2015-2019 (3)




#### Return on assets 2015-2019 (1)
